Phase II – Demolition

The first floor of the building will be removed in its entirety to include: all walls, ceiling, fixtures, cabinets, flooring, electrical fixtures and wiring, ductwork, etc. The chosen contractor will follow 2018 building code and OSHA subpart T standards to demolish the interior of the building safely. **The structure and the masonry of the building shall be protected from damage**. Manual demolition and mechanical demolition, only, will be allowed. No torches, fire, or chemical demolition will be allowed.

Sanitation of the interior will be required before and during demolition to keep the workers safe. Personal Protection Equipment (PPE) will be the responsibility of the chosen contractor. Sanitation of the building interior after demolition is complete is required.

Demolition will only be required on the first floor of the building. Electrical outage will be scheduled with the Building and Grounds Department.

- 2. Bidder is familiar with and has satisfied itself as to all Laws and Regulations that may affect cost, progress, and performance of the Work. especially with respect to Technical Data in such reports and drawings.
- 3. Bidder has considered the information known to Bidder itself; information commonly known to contractors doing business in the locality of the Site; information and observations obtained from visits to the Site; the Bidding Documents; and any Site-related reports and drawings identified in the Bidding Documents, with respect to the effect of such information, observations, and documents on (1) the cost, progress, and performance of the Work; (2) the means, methods, techniques, sequences, and procedures of construction to be employed by Bidder; and (3) Bidder's safety precautions and programs.
- 4. Bidder agrees, based on the information and observations referred to in the preceding paragraph, that no further examinations, investigations, explorations, tests, studies, or data are necessary for the determination of this Bid for performance of the work at the price bid and within the times required, and in accordance with the other terms and conditions.

- B. Bidder has not directly or indirectly induced or solicited any other Bidder to submit a false or sham Bid;
- C. Bidder has not solicited or induced any individual or entity to refrain from bidding; and
- D. Bidder has not engaged in corrupt, fraudulent, collusive, or coercive practices in competing for the Contract. For the purposes of this Paragraph 4.01.D:
 - 1. "corrupt practice" means the offering, giving, receiving, or soliciting of anything of value likely to influence the action of a public official in the bidding process;
 - 2. "fraudulent practice" means an intentional misrepresentation of facts made (a) to influence the bidding process to the detriment of Owner, (b) to establish bid prices at artificial non-competitive levels, or (c) to deprive Owner of the benefits of free and open competition;
